- 1) This plan is offered subject to inspection and approval of your air conditioning equipment. Any repairs required to place this equipment in acceptable condition are excluded from this Plan and will be charged separately on a time and material basis.
- 2) Upon approval and acceptance, Plan will be effective immediately. Preventive maintenance and combustion service to be performed during the period the Plan is in effect at the mutual convenience of the Customer and Company.
- 3) This Plan is in effect for one (1) cooling season, and must be paid within 30 days. Any repairs made before payment will be subject to normal service charges.
- 4) Service calls resulting from blown fuses or circuit breakers, oil burner emergency switch turned off, thermostat not properly set, or electrical power failure are not covered by this Plan, and will be charged at the regular hourly rate.
- Agreement does not cover any of the following: Labor and/or materials to correct malfunction in the central air conditioning system such as: duct work, water leaks of any type, refrigerant leaks of any kind, thermostat, electronic air cleaners, blower motors, belts or controls on warm air furnaces and refrigerant recovery.
- 6) You are responsible for providing access for us to all concealed or hidden components of the heating system, for any and all repairs or replacements that arise out of our need to have access to the components, including as examples walls, partitions, floors, ceilings, chimneys, entryways, etc.
- 7) This plan does not cover general plumbing, household wiring, walls, or other structural portions of any building, or the repair, replacement, renovation or movement of any of the foregoing. This Plan also does not cover any ammonia or gas system.
- We are not responsible for the discovery, handling, treatment, removal, or safety of any asbestos or equipment containing asbestos.
- 9) We are not responsible for any additions to your central air conditioning system that are not a part of your cooling system as initially approved by us, nor will we assume any responsibility for any service performed by any one other than the duly authorized personnel of this Company.
- 10) This Plan covers residential central air conditioning units only.
- When it is no longer practical to continue servicing customer's equipment, due to age or obsolescence, Williams reserves the right to cancel this agreement at any time, or Williams will modernize customer's equipment (with customer's approval and at customer's expense) which will continue this agreement.
- 12) Any cleaning requiring more than 3 hours will be billed at our standard hourly rate.
